NATIONAL BOATING FEDERATION: Phil Arms reported that the Fall meeting was held October 21, 2006 in Virginia. Had a series of speakers one in particular from NTSB. Phil encourages everyone to upgrade their VHF radios so as to be able to utilize the Rescue 21 program when it is implemented. Funding has been approved however coastal towns need to cooperate by allowing the Tall Transmission Towers needed to operate the program be installed. He reiterated that IOBG was presently in good shape, but we need to be aware and concerned in the future and cannot go on proposing a negative budget even though we ended up the year in the black. Recognized Carol Promessi and the changes experienced over the past couple of years due to her. Fortunate to have new chapters formed in District 27 in the Chesapeake Bay area. Recognized and thanked Chuck Browning for his work. Stated that District 26 growing by leaps and bounds with new Auxiliaries forming. Thanked the Area VP's and District Directors.

PRESIDENT ELECT: Carol Promessi recognized nominating committee. Thanked Debbie for her work in District 50, and recognized District 27 and acknowledged Districts that sponsored new Charters into the various Districts. Website has chapters by Districts. Can utilize the website to see what yacht clubs are in the area.

PRESIDENT: Smooth year and thanked the bridge and all members for their support. Brought up the resolution that was presented to him about assisting the Power Squadrons and Coast Guard Auxiliaries in Boater Safety Education. Stated the proposal was lengthy, with where as and therefores. George Knies proposed that IOBG shall now promote boating safety classes that are now being offered by the U.S. Coast Guard Auxiliary and Power Squadrons mandated by State. The extent of IOBG involvement shall be to encourage support boating safety courses by our chapters and districts. Joe Tringali moved that we adopt George's proposal. The motion was seconded by Louis Keys. Motion passed.

**OLD BUSINESS:** None

**NEW BUSINESS:** Carol Promessi presented the proposed budget for 2007 for approval. She reiterated the proposed increases in the area of insurance, postage, printing of log. Motion was made by Larry Foote and seconded by Art Garside to accept the budget for 2007. Motion passed. See attachment

**SURVEY RESULTS:** Marshall went over the results of the survey stating that there was a 14% response and of those responding 78% stating approval for reimbursement of partial expenses at the International level and 75% approval at the District level. On the question of whether Districts should develop a reimbursement policy 80% responded to the positive. On the question of what do you expect from IOBG? The comments were numerous and varied. See survey. It was noted that surveys are a good tool to address problems within Districts and that this survey actually was created from a survey performed by District 10.

**PROPOSED BYLAW CHANGE:** Phil Arms Proposed Changes to IOBG Bylaws October, 2006. The following proposed changes to the Bylaws of the International Order of the Blue Gavel have been recommended to the Executive Committee by the Bylaws and Policy Manual Committee. They are presented to the Board of Directors for their consideration and are to be voted upon at the Annual Meeting in October in Long Beach, California.

#### Article VI, Officers

Insert Section 1(a) to read as follows:

Section 1(a). The executive Committee shall be comprised of the Immediate Past International President, the President, who shall act as the Chair, the President Elect, the First Vice President, the Second Vice President, and the Treasurer, whose duties shall include, but not be limited to, the following:

- (1) Acting in lieu of the Board of Directors between Annual Meetings;
- (2) Making appointments to fill vacancies;
- (3) Approving the Annual Meeting Committee Report and other Committee reports;
- (4) Reviewing and ruling on Chapter Applications not meeting IOBG requirements;
- (5) Approving expenditures exceeding the budget;

- (6) Reviewing applications for Auxiliary groups; and
- (7) Researching and preparing subjects to be brought before the Annual Meeting.

All actions by the Executive Committee shall be by majority vote. All actions by the Executive Committee are subject to review by the Board of Directors at its next regularly scheduled meeting and must be ratified either in meeting assembled or polled by mail ballot.

Delete Section 3 (b).

Delete Section 8 as written and substitute the following:

"Section 8. The Licensed Contractor shall serve as the main point of purchase, manufacture and distribution for all IOBG insignia, regalia, and paraphernalia for the IOBG by distributing to the membership via the District Supply Officers. In the event a District has not designated a Supply Officer, the Licensed Contractor may service orders directly to the member. The Treasurer shall provide the International Officers stationary, business cards, and name badges to meet their needs. The Licensed Contractor shall operate in accordance with the current Contract for Service agreement in conjunction with the Treasurer under the oversight of the Executive Committee."

#### **Article IX, Committees**

Section 1., delete "Executive Committee," "Membership Committee," and "Administrative Committee," so that the Section reads as follows:

"Section 1. The Standing Committees of the IOBG shall consist of the Nominating Committee, Annual Meeting Committee, Audit Committee, and the Bylaws and Policy Manual Committee."

Delete Section 3.

Renumber Section 4 to Section 3.

Marc Connelly moved and Joe Tringali seconded to accept the changes to the Bylaws as proposed by Phil Arms. Motion passed.

Bill Young accepted a check for IOBG's membership dues in the Royal Navy Lifeboat Institute.

### **NEW CHARTER APPLICATIONS: Carol Promessi**

North Palm Beach Yacht Club Auxiliary application. Motion made and seconded for approval. Passed

Application for Blue Whale Boat Club in District 25. Motion made by Richard Janiszewski to accept the application. George Knies seconded the motion. Motion passed.

A third application was from Anchor Bay Yacht Club. They have 29 members and 28 past Commodores. Richard Janszewski so moved for acceptance and seconded by Joe Tringali . Motion passed.
