TREASURER MARSHALL NEMOY REPORT:

Passed out the Treasurer's report and the information in this report should be shared with all members of IOBG. The financial statements contained in this report are as July 31, 2007 and seven months then ended. The report shows the Budget for the International Operations Center, Executive Committee, Annual Meeting, Area Vice Presidents, and Blue Gavel Log. The 2008 budget will be presented by President-Elect Richard Janiszewski. The membership statistics attached to this report are as of August 1, 2007and 2006. A list of the districts and votes allocated to them will be mailed to the officers and directors entitled to vote at the Annual Meeting.

Here are a few items that will be of interest to all members:

- 1. Our membership year ends September 30, 2007. Dues received after that date will be credited as 2008 dues unless specified otherwise. This is an accommodation to members who travel south for the winter.
- 2. Dues must be sent to your district treasurer. Sending the dues directly to the I.O.C. will only delay the processing of your membership card. Be sure your district treasurer sends in a dues transmittal in a timely manner.
- 3. For your convenience you may be notified that the BLUE GAVEL LOG has been published on the web site, www.iobg.org. Just send us an email at bgtreas@iobg.org and we will put you on the notification list. This is particularly useful for those who change locations with the seasons.
- 4. Please notify us when you change your mailing address. 98% of the time we learn about your new address from the returned BLUE GAVEL LOGS. By policy we do not re-mail the returned Logs. Also, be sure to notify your district or they send in your dues with the old address and process starts all over again.

Ask for questions from the floor. No questions.

President Carol Promessi asked that the Treasurer's report for 2007 Summer Regional meeting be approved. Treasurer's Report was accepted, seconded and approved as submitted.

2nd VICE PRESIDENT RAY THOMPSON REPORT:

Thank you both. At this time De has already signed up 3 new members from this meeting and he isn't done yet! If it had only been one new member that would have been great! That is what IOBG is all about, getting members and their Districts working together.

The biggest accomplishment has been the signing of the MOU by the USPS. This is to encourage squadrons, districts, and yacht clubs working together with the yacht clubs to provide a possible venue for courses and meetings. IOBG is also into an agreement with the USCG Aux., which we are still awaiting approval.

District 8 is working very well with an Ambassador program.

District 18 is not too good, the leadership is weak. IOBG is a supporting member of US Sailing and I have submitted a letter requesting marketing devices for our Annual Meeting. They have a weekly e-newsletter which has a wealth of information in it. EPA permits and boat operator licensing are still two big items of information to boaters. The US Sailing Annual Meeting will be held in Scottsdale, AZ this year.

U.S. Coast Guard Auxiliary Larry Draper: No Report.

National Boating Federation Art Garside: Phil Arms is in charge of it, so take my name off of it for next year. No Report.

President Carol Promessi received by E- Mail from Phil Arms a website for Buoy Information. It is called "Dial a Buoy" By E-Mail it is www.ndbc.noaa.gov/dial.shtml. or call 1-888-701-8992 by cell phone. If you are out on your boat (on the water or not) and want to know what is going you can dial a buoy on your cell phone and get the weather & data needed.

Joan Marsh Clune and Jerry Rudd brought up the law up before U.S. Congress HR 25.50 about the permit on discharge from recreation boats. It would be very hard to afford boating if this is not approved. Be aware of it and get your representatives and boaters behind this bill.

IOBGA Liaison Ray Thompson: No Report.

IOBGHF Liaison Phil Arms: Absent. No Report.

Members Leadership/Public Relations Art Garside Report:

I have sent out 30 letters to different publications and have not had a good response back yet. We need to get IOBG name out. Some districts have been sending the letter out and getting it published Jerry Rudd and District 19.

BYLAWS and POLICY MANUAL Phil Arms: Absent. Report read by Marshall Nemoy.

Answer: It was bought up at the Executive Committee meeting and at this time in the best interest of IOBG not to go forward with the request and President Carol Promessi is writing a letter to District 8's President Jack Kennedy to explain the decision.

I am sending out notices to the Area Vice Presidents and District Directors for the Annual Meeting with different forms to be filled out and returned. In the package there are forms for the new slate of Officers, applications, and who is coming to the meeting. ELECTIONS of DIRECTORS of the IOBG HUMANITARIAN FOUNDATION

The bylaws of the IOBG Humanitarian Foundation specify that the Executive Committee of the IOBG are the Trustees and voting members of the Foundation. There are three classes of membership in the Foundation:

Voting members (Trustees), Regular Members (All members of IOBG) and Humanitarian Members (those who are not members of IOBG but support the Foundation and its work). The Voting Members are the ones who elect the Directors of the Foundation.

The Chairman of the Board of the Foundation appoints a Nominating Committee to select qualified candidates for election to the Board. This Nominating Committee shall make its report at least 60 days before the date of the election at the Annual Meeting of the Foundation. The Annual Meeting of the Foundation shall be held in conjunction with the Annual International Convention of IOBG. Nominations by petition may be made at least 45 days prior to the election. Therefore, the nominating committee should report no later than August 21st, and nominations by petition should be received no later September 5th.

The committee is: President-Elect Richard Janiszewski, Second Vice President Ray Thompson, and P/P Phil Arms (Executive Secretary to the Trustees of the Foundation). The Foundation Nominating Committee makes their report to this committee, and nominations by petition should be forwarded to them.

We have available in Foundation Budget, \$47,393.00. We are working hard to get the word out about what we can do for boating and what the membership can do for the Foundation.

District 15 President Linda Loftis presented to IOBGHF President Joan Marsh-Clune a check for \$500.00 from the Wine and Cheese party held at the Point Loma Yacht Club in San Diego.

SUPPLY OFFICER EARL HOHLMAYER: Absent. Marshall Nemoy reported that the Shoulder Board called Wavey/Navy has been authenticated. A list of members will be given as to who can buy IOBG material from Supply Officer.

Joan Marsh-Clune said the IOBG Auxiliary order is separate from IOBG.

Discussion followed about the look of the Shoulder Boards.

OLD BUSINESS:

MARKETING COMMITTEE Marc Connelly: No Report.

NEW BUSINESS:

Chapter Applications: President-Elect Richard Janiszewski reported that we have 2 Chapter request.

Motion made by Richard Janiszewski to accept applications from

Yacht Club of the Yacht & Country Club – District 8 Second by Jerry Rudd. Motion was approved. Motion made by Richard Janiszewski to accept the application from Cape Fear Yacht Club – District 50

Second by Marshall Nemoy. Motion was approved.

PROPOSED BUDGET for 2008

Treasurer Marshall Nemoy stated that one of his tasks, as required by the bylaws, is to assist the President-Elect in the budget process. Based on his experience, and the fact that we have had two years of losses, he gave President-Elect Richard Janiszewski the following estimates for expenses in 2008.

Based on the assumed number of members for 2008 and the average attendance at the Annual Meetings, reduce this expense somewhat. Constants are the Executive Committee travel to Regional Meetings, Area Vice President's travel allowance, The IOBG LOG, there are some ideas to reduce this, and the IOC.

President-Elect Richard Janiszewski thanked Marshall Nemoy for all his hard work.

Looking long and hard at everything, the membership has been in decline in the last two years.

Reduced the expenses by 5%, some ideas are on the Log and postage reduction.

We have lost about 20% of the membership in the last 5 years.

Recommend a dues increase of \$10.00 per member per year to start in 2008.

Art Garside asked a question about the increase in dues. What has been budgeted out, and worried that a dues increase will loose membership.

Marshall Nemoy answered citing the survey taken last year which stated that 78% to 79% were okay with the travel policy and the Districts discussed raising their own dues so their District Directors could attend Annual and Regional Meetings. Not sure about how many, 3 or 4, Log newsletters should be issued. If we loose some members over the proposed increase of dues, are they really interested in IOBG.

Also, P/P Art Garside asked what reduction the Committee has discussed.

President-Elect Richard Janiszewski discussed travel pay for the Log Editor and Legal Officer. It was discussed that the Legal Office would receive per diem for the Annual Meeting.

The Log is very costly and we are talking about not so many pages in it.

Look at going from 4 to 3 meetings a year.

The Log from 4 to 3 issues.

Looked at the AVP budget, but realized if we cut back we could lose on some of their travel to find new Chapters and assist their districts personally.

Everything is on the table.

A lively discussion followed:

Herman Meyer proposed an increase in dues of \$10.00

Vote will be taken at the October Meeting.

Steve Willing said Great Lakes Association is starting up again and could take some IOBG Members.

Mary Nye Meyers said printing is less than it was 5 years ago.

Marshall Nemoy talked about the marketing of IOBG saying Marketing won't work if you don't believe in it.

President-Elect Richard Janiszewski will send a letter out to all members explaining the dues increase.

Marshall Nemoy will draft a letter and have the Executive Committee check it over and have President-Elect Richard Janiszewski sign the letters.

It would be about 2600 letters to the membership. Have it done very quickly, long before the Annual Meeting. Joan Marsh-Clune thought the 33% raise of the \$10.00 dues increase would be a hard sell.

Phil Promessi said don't talk %.

Marshall Nemoy explained the rate increase again.

Art Garside asked Marshall Nemoy, how many do you think we will lose. Answer: About 150 people.

Tom Sullivan suggested to partnership with a National Chain.

Answer: not enough time. (not sure who said that).

Election packages will be going out soon.

Art Garside asked if a bylaws change was needed on the dues increase.

President-Elect Richard Janiszewski says it is not needed by our bylaws.

Marshall Nemoy said no bylaws change, please.

President-Elect Richard Janiszewski closed the discussion and asked if anyone had any further ideas or input, please let the Executive Committee know.

COMMUNICATIONS:

President Carol Promessi sent out a Get Well card to Alan Eiffert (husband of Executive Secretary Mary Eiffert) and a Sympathy card to IOBGA President Pat Graven on the death of her husband Director District 7 Bob Graven.

GOOD of the ORDER:

President Carol Promessi presented an Appreciation Plaque to De Ramsey.

De Ramsey thanked everyone for coming to this out of the way meeting place.

President Carol Promessi talked about the District 3 is holding a Memorial Benefit this weekend at Sandy Beach Yacht Club for Trooper David Brinkerhoff, New York Policeman, who was killed in the line of duty.

Announcement:

President Carol Promessi discussed the plans for dinner and the Boat ride after dinner. Past President Harvey Sussel thank everyone for their support and cards for his wife Bonnie Sussel.
