1. Delegate Travel Allowance at the Annual Meeting:

The proposal is to prorate the travel allowance according to the numbers of meetings attended. If a delegate only attended one of the 3 scheduled meetings, they would receive one-third of the stated delegate travel allowance.

2. Assignment of Alternate Director:

The proposal is that the alternate district director must be a dues paying member as of August 1st of the district they will represent. Further, the accreditation statement for the alternate director must show that the individual was elected by the district to serve in that capacity. Report Submitted.
