# **EXECUTIVE COMMITTEE REPORTS:**

**PRESIDENT ELECT:** Ray Thompson said: I thank you for the opportunity to serve as your President Elect. Hopefully my efforts will be sufficient to satisfy all the requirements this office demands. During the past several years IOBG has been plagued with an inordinate amount of internal criticism regarding certain operating policies. Now the escalation of the criticism along with ensuring frustrations has been serious enough to cause the resignation of District 8's Board of Directors as well as a number of Chapters. The negative potential of all this criticism makes it imperative that I commit my efforts to the reducing of as much of these critical areas as possible. My commitment will never be successful with out the full cooperation and support of all the members. Therefore, it is hoped that District Directors would poll their membership on all these trouble-some issues, which in turn, would help produce democratic and more easily defended solutions. Solutions that would resolve internal frustrations would permit more time and effort for our involvement in the support of water and boating activities.

I had planned to have the IOBG Annual Ball at Palm Coast Yacht Club, that is being changed and by the June Regional Meeting the new place will be announced.

A meeting is scheduled for Friday, February 19, 2009 in Florida and President Jerry Rudd will be attending.

#### **COMMITTEES:**

BY-LAWS: P/P Carol Promessi: No Report.

**NOMINATING:** President Jerry Rudd said if you are interested in holding an elected position you must send a letter requesting it to anyone in the Nominating Committee. The committee consists of Chairman Ray Thompson, 1<sup>st</sup> Vice President Vern Bendsen, or Immediate Past President Richard Janiszewski. The Letter must be in by the August Meeting.

**CONVENTION (2009):** President Ray Thompson: No Report.

Treasurer Marshall Nemoy said IOC would provide the labels and let them take care of the mailing and printing out of the funds authorized by this vote if passed, except for the four Chapters who have officially dropped out,

Ouestions:

Carol Promessi asked that some District funds have already been collected. Why don't you use those funds?

Response: Treasurer Nemoy said District funds submitted to the International should be held in escrow for the District like we do for District 18. He advised that the IOBG Bylaws and District 8 Bylaws should be followed to the letter.

Pat Sheffield asked is there a need for a lawyer and also stated that Florida Law protects the funds. President Rudd response: One problem is when the IOBG District 8 Board resigned en masse there is nobody with the legal authority to act in behalf of District 8 until there is an election. Motion passed.

CODE of CONDUCT – LIFE MEMBERS: Our Bylaws are silent on Code of Conduct. Last year President Richard Janiszewski bought this idea to the Executive Committee. On the Committee is Immediate Past President Richard Janiszewski, 1<sup>st</sup> Vice President Ray Thompson, and Past President Carol Promessi, and Legal officer George Knies. Past President Carol Promessi read the draft proposal. Discussion followed.

Ouestion:

Russell Libby asked where in our Bylaws would this be placed?

Response: The Bylaws Committee will take this draft under advisement and decide where it would be placed in the IOBG Bylaws.

A motion was made to recommend this Draft to the Bylaws Committee.

Discussion followed.

Motion was made and seconded. Motion passed.

# BY-LAWS CHANGE - IS THERE ANY NEW SUGGESTIONS: LIFE MEMBERS PAY DISTRICT DUES:

Treasurer Marshall Nemoy said at the Annual Meeting in Seattle, we had a discussion about voting as an Alternate Director. Some problems have come up. We have members who do not pay District dues because their District does not make Past District Presidents pay dues. International Past Presidents do not pay International dues.

How do we certify that this group as a Alternate Director is eligible to represent that District? Discussion followed.

Districts 50 and 51 Alternate Directors are appointed by the Executive Committee and those Chapters do not pay District dues because District 50 and 51 do not charge District dues; but do pay International dues. The Alternate Director must be a paid up member of the district he or she represents.

Have to name an Alternate Director by a certain date

Still needs to work on this, just keep it simply for a Bylaws change.

**CHAPTER APPLICATIONS**: We will postpone this discuss until 1<sup>st</sup> Vice President Vern Bendsen is present.
