TREASURE MARSHALL NEMOY REPORT:

We are doing better than last year. The financial statements in this report are as of September 30, 2011 and the results of operations for the nine months then ended.

So far the 2011 year is continuing the pattern of recovery from the events that occurred in 2009. With one regional meeting eliminated from the schedule and the creation of the news bulletin, "The Lighthouse" as a vehicle for delivery of an electronic edition of the "The Blue Gavel Log", we have been able to reduce costs to avoid raising the dues.

Some questions have come up concerning the members who belong to more than one Chapter in the same District. The member pays both chapter dues but only paid one District Membership dues from the chapter he or she chooses.

Another one is if the member wants duel membership in two different Districts, he or she must choose where he or she wants his or her IOBG Membership card to come from and that District will get the vote count. He or she will still pay the Chapter dues but the IOBG dues will be from the District he or she chooses according to the Bylaws. International will count only one vote for the member and that member must make the decision of which District he or she wants.

Another is a Member At Large whose Club is not a member of IOBG, in the IOBG Bylaws, Article Ill state what must be done, and has to be a Commodore of a Club that would quality as a chapter defined by IOBG and not a member of another District. You must send a letter to his or her Club if that person did serve as Commodore in a creditable manner and if the reply is approved. Then you have the opportunity to grant membership to that person.

Another question is which Districts get bills from IOC. District 50 and 51 are administered by IOC. We also send bills out to District 18, 20 and 22 memberships.
