IOBGA PRESIDENT JUNE THACKER REPORT:

IOBGA is alive and well. The membership is running consistently as it has in the past. NATIONAL BOATING FEDERATION GARY GREEN REPORT:

NBF is a group working on two major projects. One is the mandate that was voted into put Ethanol 15% in our gasoline. A nation wide Congressional study found out that this would increase our corn, gas, green house emissions. It is also very bad for our Boat engine and it is being looked into getting more information on it.

2nd the Coast Guard wanted to reduce the visionary aid to our Southern CA ports. It would reduce or stop all together the navigation markers in areas like Channel Islands and the U. S. Coast Guard decided not to do that because of concerns for the safety of the Boaters. You should be aware of this if it comes into your areas. NFB works on behalf of the interests of all recreational boaters. It represents no commercial interests or sells any products; it relies on the support of membership from all Boaters.

US SAILING BILL THAYER REPORT:

With a new generation of athletes pushing established veterans to higher levels of performance, the team is coalescing around a single goal: getting the United States on the podium.

US Sailing now offers a new PHRF Support Service designed to manage sailboat data and rating information for fleets.

The 2014 Hurricane Season runs from June 1 to Nov.30. The Growing Group recommends you all prepare by visiting the Growth Sever Storm Center to assess our resources. Report Submitted.

IOBG HUMANITARIAN FOUNDATION VICE PRESIDENT ESTELLA McGRATH REPORT:

Started the report with some questions? Who is the Liaison Officer for IOBGHF? President Gary McGrath said Past President Vern Bendsen was appointed and the IOBG President appoints one each year.

IOBGHF Vice President Estella McGrath said that neither President Nies nor she was asked for a report.

We are looking for a representative from the East; please let President Ira Nies or I know who would like to join us on the IOBGHF Board.

At the meeting there were letters presented to the Board about each person qualifying for the IOBGHF Board. I need the original letters. President Gary McGrath will give them to IOBGHF Vice President Estella McGrath.

IOBGHF President Ira Nies is setting up to have conference calls.

We need ideas to get funds into the Foundation, so we can do the work the Foundation is set up for.

We need a Legal Officer to be sure we are doing the Foundation work correctly. There must be in the IOBG a lawyer who could help us.

We are setting up the responsibility for each Officer and Director.

Also, asking for a monthly report on what is going on in your position and it will be sent to me. We are asking that IOBGHF meetings be held before or after so we all can attend the IOBG meeting.

Discussion followed on how IOBGHF funds were used in different IOBG locations.

It was asked to put out a guideline on how IOBGHF Pins are obtained. This is being worked on and we just receive new pins.

COMMITTEES:

FINANCIAL & BUDGET TREASURER MARSHALL NEMOY REPORT:

Yesterday at the Executive Meeting we talked a lot about our finances and how we managed the funds.

There are two (2) parts: One that affected the operation and we haven't changed that part in years. Our costs keep going up and our dues are \$40.00 Dollars a year

We agreed to the recommendation by our Legal Officer Gary Green to have an Insurance policy for the Board.

We agreed to have AVPs have travel expenses to come to the meeting that includes Air Fare and per diem just like the Executive Board. The reason for that is the AVPs have been historically the resource the nominating committee has used to select to go up the change of command. It beholds us to train out future Officers to go up the ladder. Sometimes some information is only heard at the Executive Committee meetings.

We would like to raise the dues by \$10.00 per member per year. We also agreed to increase the funds to the Executive Committee who have come to Annual Meeting and up it to \$100.00 Dollars more at each level. On this we shouldn't have to raise the dues, we have a incremental stipend that is put in every years funds for everyone for the Executive Committee and for those who do show up, we have funds for that.

A vote was taken to approve the budget increase for our dues for 2015 to be raised to \$50.00 Dollars.

We took into account we could loose some members. There are various motivations for being a member of Blue Gavel. We have to remind all members prices in every area have gone up. We have gone to three (3) Meetings a year and now send out the LOG electronically and only 37 members asked for it to be sent by mail and they are charged for the service.

The Executive Committee is purposing to the Board of Directors that the Membership dues be raise to \$50.00 a year.

A package will be sent out by September 18th on this proposal. Also, a notice will be sent to the District President and District Treasurer about the proposal to be aware if it is approved, it would

be \$50.00 Dollars for 2015. So if a member paid early of just \$40.00 Dollars, they would still need to add \$10.00 Dollars more to get a 2015 membership card.

The Executive Committee is recommending to the Board of Director we purpose a \$10.00 increase.

A total package will be sent out by September 18, 2015 to all. This conformed to the 30 days notice.

Discussion followed. Many ideas were put forth on how this proposal would go over with membership. The main thing was to let the membership know it is coming up at the Annual Meeting, to let every member know so we can get good feed back from all and those who pay early would know ahead of time there could be an extra \$10.00 charge to be paid for their card, if this proposal is passed.

AUDIT PRESIDENT ELECT JOEL KAY REPORT:

After a most thorough review of the Treasurer's submissions dated May 14, 2014 with additional explanation, we fully support Treasurer's report.

Submitted by Past President Chuck Browning, President Elect Joel Kay and 1st Vice President Joe Dowdell. We asked for approval of the Audit Report. Motion made to accept the Audit Record by SWVP Mike Billington and seconded by Past President Vern Bendsen. Motion passed. Report Submitted.

BYLAWS and POLICY MANUEL REPORT VERN BENDSEN REPORT:

In June, 2010 there was some grammatical errors in Article 7, Section 2 and there will be a mail in ballot to correct the wording. Report Submitted.

COVENTION - 2014 PRESIDENT ELECT JOEL KAY:

The Annual Meeting will be held on October 16th thru 18th at Double Tree Hilton in Beachwood, Ohio. The Airport is about ½ hour to 45 minutes to the Hotel, There is no scuttle service to the Hotel but you can get a shuttle to the Hotel or if you rent a car, it is free parking at the Hotel.
