## **EXECUTIVE COMMITTEE REPORTS:**

## PRESIDENT JOEL KAY REPORT:

Despite the dues increase for 2015, the members that were lost, by and large were not a result of the increase. The dues increases enabled the AVPs to attend Regional Meetings by helping pay their travel for them. By having most of the AVPs at the Regional Meetings, the communication level increased from them to their districts and chapters.

More members are opening the "Lighthouse" and "Log". This is the best form of membership by communicating to the general membership what is going on within the organization.

Last year, Past President Gary McGrath created monthly conference calls for the Executive Committee. These were continued nearly every month in 2015. They also contributed to getting the word out to the

membership by creating a very transparent way of handling IOBG business. Also changes in the Bylaws and Policy Manuel were made to ease the confusion of accepting dues in a year when a dues increase was approved by the Executive Committee. The Humanitarian Foundation's reorganization was approved by the Executive Committee. The Humanitarian Foundation has been reorganized and it was determined that only two Area Vice Presidents may serve on its Board in any one year, a major step in the Foundation's ability to govern effectively.

This has been a most interesting year for Nancy and me. I encourage all members to become interested in the operations of the Gavel, as it has been most rewarding for me. Report Submitted.

## PRESIDENT ELECT JOE DOWDELL REPORT:

In 2005 the Blue Gavel were surveyed via a questionnaire included with their membership, The response rate back was 25%. The average length of membership of IOBG membership was 10 years. At that time few visited the IOBG website. Another survey was sent out in 2006 and its response was then14%. The three questions that were asked:

- 1. Should the members who serve at the International level receive reimbursement for their travel in accordance with existing policies?
- 2. Should members who serve at the District level receive reimbursement for their travel in behalf of the District?
- 3. Should District establish programs to fund the travel expense for their representatives? If you answer no to any of the three questions, what would you recommend for a policy concerning travel reimbursement?

Since these surveys were conducted we have had 2 dues increases and decrease in membership. I think it is time for another survey, including an "exit" survey to those that have not renewed their dues in the past two years. A proper well drafted survey can be expensive but in light of what has transpired over the last 10 years, I believe it is necessary and worthwhile.

Some tasks that keep an organization going are self-gratifying. Other tasks are necessary but not particularly exciting and it help to know that people appreciated your efforts. Do we have special recognitions at change of watch for individuals, chapters and districts that have done outstanding work in the past 12 months? Morale is not good when people feel they are taken for granted.

Support-Provide encouragement, problem solving and assistance to those who are attempting to produce an event or provide a service to the local yachting community. They need to know we are all in this together.

These are basic concepts we all learned on the road to becoming a commodore. As past commodores, we are still human. We will respond positively when we feel we are treated well. If the members don't feel they are treated well, they will find other ways to serve the community. We want members to choose IOBG as their way of serving the yachting community. Report Submitted.
