OLD BUSINESS:

BYLAWS and POLICY MANUAL REPORT: Given by Chairman Gary McGrath

There are two (2) policies being changed, one is the Bylaws and the other is on the Policy and Procedures Manual. These changes will be sent out for a mail-in vote.

First one is on Bylaws change to Article VII, Section 4 which now reads:

When a quorum is present at any meeting of the Board of Directors, in person or by proxy, the act of the majority shall be the act of the Board of Directors. A quorum shall be deemed present if two-thirds (2/3) of the total eligible votes of the Directors are present.

The change is:

A quorum shall be deemed present if Fifty Five percent (55%) of the total eligible votes of Directors are present.

Second one is on the Policy and Procedures Manual as of now it reads:

Dues are due on the first of January each year, and are considered delinquent after that date. Added to that is:

As a convenience, the IOC has allowed Districts to submit their dues prior to the Annual Meeting; however, if the Board of Directors vote to increase the dues; all dues submitted to IOC early (prior to the Annual Meeting) shall be adjusted and billed the difference between the current dues and the voted dues increase.

These two changes will be a mail-in ballot proposal and you will mail the ballot back to the Office of IOC to be counted and announced at the Annual Meeting. Report Submitted.

Legal Officer Gary Green asked the additional item about the Humanitarian Officer Liaison. Past President Gary McGrath stated it will now be an IOBG Past President as the Liaison Officer with the Humanitarian Foundation.

US SAILING REPRESENTATIVE BILL THAYER REPORT:

US Sailing is proud to announce a new partnership with 11th Hour Racing, a program established by the Schmidt Family Foundation that specializes in fostering strategic partnership within the sailing and marine communities to promote collaborative systemic change for the health of our marine environment.

At this time we need members who are creative doers and that will be the key to motivate IOBG Members to help raise funds for the Humanitarian Foundation. The Foundation was set up to help different areas in our IOBG Membership to fund different projects needed in their area.

Example: District 15 had a Bicycle Team to participate in a day event to raise funds for Make-A-Wish, in this one day event with the Yacht Clubs in the area help raise over \$125,000.00. Charities events like that help get our name out there.

HF website is all over the place, one thing is needed is to change its name to reflect more boating projects like District 5 which is involved with their "Life Jacket" Program. HF mission needs to be more locally based. Start with local projects and thru that progress a larger project could immerge. Some of the questions always asked is how do we apply for a grant and where is the money going. How much money is taken in and given out for HF projects. The membership needs be informed at all the times. HF is under Tax "501-c-3", get the research done on your project to be sure that it is legal for a "501-c-3" Donation.

Projects from the Districts should be from "Bottom Up, Not Top Down". On thing is that each entity has to stand on its own.

When District 5 starts to get their Life Jacket program going, it helps to talk to people who were involved in Waterfront area and learning what was needed and letting them know what the District was doing and how to keep it going.

Treasurer Marshall Nemoy ended this part discussing how the tax donations works with HF and called on IOBGHF Treasurer Jackie Evans Rudd for further update on HF.
