APPROVAL OF FALL REGIONAL MINUTES:

It was regularly moved, seconded, and approved to accept the minutes of the last Regional Meeting held in Marathon, Florida, October 25, 2015

IOBGHF REPORT - Treasurer Jackie Rudd

Jackie reported that the Humanitarian Foundation is looking for directors. On May 21, 2016, HF funded \$600 for three scholarships to the Youth Sailing Program at Gulf Harbors

Yacht Club in New Port Richey, Florida. To continue supporting groups, the Foundation needs donations. A new treasurer is needed as Jackie is stepping down.

EXECUTIVE COMMITTEE REPORTS:

TREASURER - Marshall Nemoy

Treasurer's report was prepared for distribution and discussion at the Regional Meeting held June 9, 2016. Summary: As of April 30, 2016 IOBG had a net income of \$57, 224, which is \$401 lower than budget but \$8,449 more than last year. Total paid members as of June 1, 2016 is 1,500, which is 46 lower than this same date last year. Total assets have increased by \$21, 685 primarily because there was no February Regional Meeting scheduled this year. IOBG's net worth has increased because of the income from the previous year and the reduction of the liabilities; thus, continuing a strong financial position and stability.

Central Billing of IOBG Dues report was distributed. Marshall explained that central billing is needed in only some districts. For example, when a district quits, the balance in checking account is sent to IOC. IOC carries it as a liability and hopes AVPs can encourage them to come back. President Joe Dowdell sent survey to former members in districts with dramatic change in membership, discovering that some haven't received bills. Sending bills from IOC gets results in those districts. IOC sends to district their share of the collected dues. Will notify treasurers and presidents to keep abreast of members in district. This will increase operating costs of IOC for paper, stamps, staff time, and credit card cost of 3%. Executive Committee is interested in Districts' input on this possibility.

SECOND VICE PRESIDENT - Bud Higginson

Unable to attend. Goal to communicate with AVPs west of the Mississippi to discuss mutual thoughts about increasing membership and improve retention program has been delayed due to a personal health issue, which is improving. Bud is looking forward to seeing everyone at the Buffalo Regional meeting in August.

FIRST VICE PRESIDENT -Tony Durieux

Tony spoke to the district directors about working together as a team, communicate the successes. Spread the word of district or chapter successes. The Chapter will thank you for acknowledging their great work and your fellow Districts will thank you for the valuable information. When planning activities, think back to the time when you joined your yacht club. What did you look for? Tony gave an example of a Sunday Bruch cruise on the Nautica Queen out of Cleveland. The District 7 Auxiliary planned the event that included both BG and auxiliary members, bridge officers from surrounding yacht clubs, plus family and friends. The attendance was 150 +. All this goes to Retention and Recruitment. When

current bridge officers see that BG stands for more than just the PC, the desire to become part of the Blue Gavel is given extra emphasis both now and at renewal time.

PRESIDENT ELECT - Rosalie Davis Green

The long awaited IOBG brochure has now arrived and are on the tables. Much collaboration went into it. A special shout out to Mary Nye Meyers and Bud Higginson for scores of pictures. P/P Vern Bendsen helped with the precise wording. IOBGA and HF presidents were able to include information. Everyone is reasonably satisfied with it. Use the brochure in recruitment. Districts with 100 members will receive 25 brochures and districts under 100 will receive 10 to start with. When gone, request more from the IOC. The brochure is good for US use, and also worldwide. Many members have wanted something to leave with commodores of yacht clubs when visiting out of the country who might consider joining IOBG. This way people have the brochure to look at after they have forgotten what was said in the conversation.

The annual meeting will be in Marina Del Rey, October 20-22. Why participate? The first thing is that is that it gives you a chance to have your voice heard in the business of the organization, and if there is anything to vote on, your representative is there to vote. Los Angeles is a wonderful place to visit. Del Rey is the home of the incoming president, so the meeting will be at DRYC. Hotels are close, but expensive. The hotel we are using is 1 ½ miles away at \$150 a night. Activities include a visit to the Getty Museum, Long Beach Harbor cruise, and dinner at LBYC. The Grand Ball will be at Del Rey Yacht Club. Put it on your calendar. We look forward to seeing you there. Registration online starts July 1st.

PAST PRESIDENT - Joel Kay

Being a past president has allowed me more time to be involved in District 7 activities and programs. Having come from the North Central Area, Nancy and I got invited to the Commodore's Ball at a yacht club which I have visited many times in the past, but never had attended a ceremony. The 2016 Commodore promised to join the Blue Gavel in 2017. Joel also boarded the USS Cod following the GCBA Memorial Day Service. While in NZ, he received word that he had sold his boat, proving the old adage that taking possession of a new boat and selling a boat are the two best days in a boater's life.

The boating community is getting smaller, hurting the yachting and IOBG membership; therefore, retention is important. He does not have a solution to this problem but will continue to work with everyone who is engaged in working on the problem. The brochure is a great step in this direction, thanks to Rosalie Davis Green, Tony Durieux and their team for making this happen.

PRESIDENT - Joe Dowdell

Joe's report was on IOBG committees. The IOBG Bylaws and the IOBG Policy and Procedure Manual authorize and refer to several committees. The committees may be either "standing committees," appointed for a definite time, in our case, one year; or a "special committee," appointed for a special purpose. Thus we have the standing committees: Annual Meeting Committee, Bylaws and Policy Manual Committee, and Finance Committee. The president may also present additional committees, as may be required, to the executive committee for approval. Districts also have committees. All committees have a specific goal or function. Some of the committee duties and details are set forth in detail in the bylaws or policy manuals, some have none. How should those with none be operated? In accordance to Robert's Rules of Order. So, according to Robert's, it is the duty of the chairman to call the committee together. It is the duty of the committee to meet on the call of the chairman, or any two of its members. In small committees, the chairman usually acts as secretary, who keeps a brief memorandum of what is done, for the use of the committee, during the deliberations of the committee no one has a right to be present, except members of the committee. Unless agreed to by general consent, all questions must be put to vote, and instead of the chairman's abstaining from speaking on questions, he is, usually, the most active participant in the discussions and work of the committee. In order that the assembly may have the benefit of the matured judgment of the committee, a reconsideration of a vote must be allowed regardless of the time and of previous reconsiderations, and it may be moved by anyone even if he was absent when the previous vote was taken; but it shall require a two-thirds vote for its adoption. This prevents taking advantage of the absence of members to reverse action, and enables members who were absent to bring up the question of reconsideration. The committee constitutes a miniature assembly, being able to act only when a quorum is present.

When presenting the committee report, the draft is read entirely through, and then read by paragraphs, the chairman pausing after each paragraph, and asking "Are there any amendments proposed to this paragraph?" No vote is taken on the adoption of the separate paragraphs; but, after the whole paper has been read in this way, it is open to amendment generally, by striking out any paragraph, or by substituting or inserting new ones, or by substituting an entirely new paper. When the entire report has been amended to suit the committee, they should adopt it as their report, and direct the chairman or some other member to report it to the assembly. When committees are appointed to investigate, or to report upon, certain matters, the report should close with, or be accompanied by, formal resolutions covering all recommendations, so that when their report is made no motion is necessary except to adopt the resolution. When the report has been adopted by the committee, a clean copy is made. If the report is of much importance, it should be signed by all the members concurring in the report. It may be signed by the chairman alone, if so, his signature is followed by the word "Chairman." This is not to be used if other members sign. The report can contain only that which has been agreed to by a majority vote at a meeting of which every member has been notified, or at an adjourned meeting thereof (a quorum, a majority of the members, being present), except where it is impracticable to have a meeting of the committee, when it may contain what is agreed to by every member. If a committee is appointed from different sections of the country with the expectation that its work will be done by correspondence, its report can contain only what is agreed to by a majority of the members.

Please contact protocol officer Marsha Landreth if there are any questions.

How does the committee function when its members are located far apart? The answer is to utilize a free service known as freeconferencecall.com. Committee members can all attend a prearranged conference by telephone with each member calling the same number and are connected telephonically, just as though they were all sitting in the same room. The Executive Committee has been doing just that for two years and it works quite well. Contact Joe if you want more information.
